## Bequests and sample wording

The charitable bequest in your Will can provide a specific dollar amount, a percentage of your Estate, or a gift of the residue, which consists of whatever remains in your Estate after gifts to your loved ones and all expenses have been paid.

Unless otherwise directed, all Estate gifts to Vancouver Foundation of \$10,000 or more will be used to establish a permanent endowment fund in honour of the donor. Vancouver Foundation will invest your donation wisely, and grant the annual income disbursements to charities in accordance to your wishes.

The following sample Will clauses provide a few options for charitable giving at Vancouver Foundation through your Estate. There are many ways that your legacy can be structured. We encourage you to talk to your lawyer and your family, and contact us to find out more.

Grant applications will be invited from charities across British Columbia, and decisions will be guided by skilled volunteers who offer their expertise to Vancouver Foundation.

Vancouver Foundation offers the following charitable causes to choose from: Addressing Homelessness, Animal Welfare, Arts & Culture, Children & Families, Education, Environment, Health, Social Services and Youth.

To give to any one or more of these charitable causes:

## 3. Give to Your Favourite Charities

At Vancouver Foundation, an endowment fund can support one or more of your favorite charities. Your annual giving will then continue, long after you are gone. This will help your favorite charities to stabilize and plan for the future. We recommend that you contact us in advance to ensure that the charity's name is correct, and that it is in good standing. Should any of your chosen charities cease to exist, Vancouver Foundation will select a similar charity with a similar charitable purpose.

To give to your favorite charities:
